有關 2019-2020 週年會員大會防疫措施安排  
(更新:20/8/2020)

香港壘球總會天光道壘球場將於 2020 年 9 月 20 日 (星期日) 舉行年度會員大會。為保障參與會員的健康及安全，本會將密切監察有關新型冠狀病毒病的發展及加強球場內的清潔消毒，並實施以下防疫措施：

天光道壘球場防疫措施：

- 與會者如有呼吸道不適症狀(例如:發熱、咳嗽、喉嚨痛及氣促等)、14 天內曾有外遊記錄或與 2019 冠狀病毒病確診者有緊密接觸者，請勿前往本球場出席會議。
- 與會者進入球場時，需接受體溫檢查，體溫高於攝氏 37.5 度之人士將不能進入球場範圍，並建議前往醫院或診所治理。
- 所有與會者必須填寫健康及旅遊申報表，以作聲明並未曾於過去 14 天有外遊紀錄、無呼吸道不適症狀 及 未有與 2019 冠狀病毒病確診者有緊密接觸。
- 進入球場前，所有與會者需使用本會提供之消毒搓手液清潔雙手。
- 與會者於球場範圍內必須時刻戴上口罩。
- 會議期間，球場範圍內嚴禁飲食。
- 與會者將被分散於不同區隔範圍，每個範圍容納不多於 20 人。
- 如打算當天到現場參與會議之會員，敬請於二零二零年九月十四日或之前填寫以下 Google form，以便本會預計出席人數，作出相應安排。

Preventive anti-epidemic measures for Annual General Meeting 2019-20  
(Updated at: 20/8/2020)

The HKSA Annual General Meeting (AGM) 2019-20 will be held on Sunday 20 September 2020 at Tin Kwong Road venue (TKR). To ensure the health and safety of all attendees, HKSA will closely monitor the situation of COVID-19 and strengthen cleaning works in the TKR venue.

Also, the following measures will be taken to ensure a safe environment for all:

- If attendees have respiratory symptoms, such as fever, cough, sore throat or dyspnea, etc., a 14-day travel history or have close contact with a confirmed case, they should not attend the AGM.
- All attendees are required to conduct mandatory temperature screening before entry. If the temperature is above 37.5 °C, entry will be denied and the attendees are advised to seek medical attention.
- All attendees are required to complete the Health and Travel Declaration confirming that they have not been out of Hong Kong within the past 14 days, have no respiratory symptoms and have not been in close contact with a confirmed case.
- All attendees must use the hand sanitizer provided to clean their hands before entering the TKR venue.
- All attendees must wear a mask at all times during their stay in the TKR venue.
- Eating and drinking are prohibited in the TKR venue during the AGM.
- All attendees will be separated in different partitioned areas, each accommodating not more than 20 persons.
- In order to better manage the number of members that may attend the meeting, members who wish to attend the meeting in person, please pre-register via the google form below on or before 14<sup>th</sup> September 2020.
