2. All Hong Kong residents who would like to purchase 20th Asian Games Aichi-Nagoya 2026 admission tickets should complete this Ticket Application Form. The form includes 4 parts. Please read through this instruction together with Terms and Conditions for completing Ticket Application Form. Submission of ticket application shall indicate customers acknowledge and agree to all these terms and conditions of sales.
3. Please fill in the Form in black or blue non-faded pen and write legibly. China Travel Service (H.K.) Limited (Abbr. CTSHK) will not be held responsibility of unsuccessful ticket application due to illegibility.
4. Please complete the form and email us at ag2026noc@ctg.cn.
5. Ticket Application and Sales is only open to Hong Kong identity card holders aged 18 or above.
6. CTSHK will collect personal information in the process of ticket application and sales. CTSHK may forward your personal information collected to **SF&OC or AINAGOC** for security reason. CTSHK is committed to protecting the privacy, confidentiality and security of the personal information we hold by complying with the requirements of Personal Data (Privacy) Ordinance with respect to the management of personal information. Unless the data subject gives consent otherwise personal data should be used for the purposes for which they were collected or a directly related purpose and kept no longer than necessary.

1. Each applicant can only submit one application form. For each games' session, each applicant can purchase up to a maximum of 4 tickets. The computer system will automatically adjust the quantity of tickets based on the above ceiling if the input number is higher than the maximum allowed.
2. If the price category of the tickets requested is not available, we will offer tickets of the same session but at a lower price category, until no tickets are available. If you are willing to accept tickets at a lower price category than your request, please indicate by marking an "✓" on the Form.
3. If the session date/time/sport/session codes do not tally, CTSHK will take session codes as the final request to proceed.
4. If the price category and unit price do not tally, CTSHK will take price category as the final request to proceed.
5. Ticket prices are set by AINAGOC. CTSHK will only accept HKD for transaction.
6. A handling fee approved by AINAGOC will be collected by CTSHK. Ticket prices and handling fees are listed out separately in the "20th Asian Games Aichi-Nagoya 2026 Schedule" for all sessions.
7. All event dates, time, sessions and venues are subject to final confirmation by AINAGOC. Please refer official website for details: www.aichi-nagoya2026.org.
8. No cancellation for all Ticket Application submitted. Tickets are allocated by AINAGOC. Applicant will receive email if he/she successfully applies the ticket. For those unsuccessful applicants, please identify whether he/she will join the second-round ticket application (if applicable).
9. Please keep all the Notification/Confirmation Letter, Payment Receipt, Ticket Exchange Coupon safe and sound in exchange for the final admission tickets in due course.
10. All ticket purchasers agree that all tickets bought cannot be re-sold or used to promote any person, entity, product or service. Ticket purchasers agree to hold responsibility for violation of the above.
11. If the Games are cancelled or if AINAGOC ceases to be responsible for organizing the Games, ticket purchasers agree not to bring any claim or take any action for indemnity, damages or compensation against SF&OC, AINAGOC, and CTSHK.
12. Tickets purchased once sold will not be refundable, unless specified by The Aichi-Nagoya Asian Games Organizing Committee or the match is cancelled.
